Audit of Benzodiazepine, Zopiclone, Gabapentin and Pregabalin prescribing within Derby Drug and Alcohol Recovery Service (DDARS) and Primary Care for those patients who are on opiate substitute medications

Objectives

- Analyse the prescribing of Benzodiazepine, Zopiclone, Gabapentin and Pregabalin to determine the following:
 - Number of Patients
 - Breakdown of the prescribed drugs •
 - Dosage •
 - Prescribed Service
 - Regime
 - Comparison to previous audit cycles

Participants and Design

- This was the Fifth audit cycle (01/07/18 30/09/18). This included both DDARS and Primary Care in Derby City due to shared Electronic Patient Record access on SystmOne
- 139 out of 834 patients were on the above medications
- 40 out of 834 patients were excluded from the audit as their GP surgeries are on a different Electronic Patient Record
- All previous four audits were only for Benzodiazepines prescribed within the service and did not include Primary Care


Measurements


• As per the objective, patients were classified based on the drugs prescribed and service

Patients were categorised 1-8 according to their benzodiazepine treatment regime.







 - dependence, hypnotic, manage difficult emotions or anxiety
- Accordingly, other bio psychosocial interventions should be considered
- Started working with Primary Care to address this issue
